

### **3/18/25**

- A Franklin Avenue motorist was arrested for driving with a license suspended for a prior DWI, driving through a private area to avoid a traffic light and uninsured auto.
- A vehicle was reportedly damaged while parked unoccupied in a private parking garage.
- A Clinton Road truck operator was charged with aggravated unlicensed operation, overweight vehicle, and unsecured load.
- Officers responded to a residence for an alarm and found an unlocked door. Upon investigation, all appeared to be in order.
- A Meadow Street motorist was charged with driving with a suspended license, unregistered auto, and uninspected auto.
- A Rockaway Avenue motorist was charged with driving in violation of a restricted license and excessive speed.

The investigation is ongoing.
- A business reports multiple unauthorized transactions were made against the company's bank account.
- An Officer responded to Kilburn Road for a fallen utility pole blocking a sidewalk. The pole was moved away from the sidewalk, and DPW was notified.
- Two Stewart Avenue motorists were charged with driving with a suspended registration and additional violations.
- GCFD and GCPD responded to a restaurant for a fire alarm activated by oven smoke.
