

7/29/25

- Upon investigation of the theft of a wallet from the Adelphi University Fitness Center, Garden City Detectives arrested a 19-year-old male for Grand Larceny. The incident occurred on April 30, 2025.
- A Hilton Avenue motorist was charged with aggressive driving violations (speeding and passing a Stop sign).
