

**8/19/25**

- GCFD and GCPD responded to a fire alarm activated by a plumbing issue, an alarm activated by shower steam, and an alarm that was deemed to be a system malfunction.
- A Franklin Avenue truck operator was charged with driving with unsecured heavy machinery.
