

## 11/18/25

- A victim responded to a bank to withdraw money after receiving a phone call stating that her bank account had been hacked. Bank personnel determined it was a scam and terminated the transaction.
- Two Washington Avenue motorists were charged with driving with suspended registrations.
- Checks mailed from the Stewart Avenue Post Office were reported to be stolen, altered, and cashed.

- Officers arrested a 47-year-old male for Harassment after he struck and shoved another family member.
- Packages were reported stolen from the front porch of a Clinton Road residence.
- A Clinton Road motorist was charged with driving in violation of a restricted license and excessive speed.
- Twenty pounds of medications collected by the Department were disposed of through official channels.
- Firefighters and Officers responded to two fire alarms that were activated in error.
